Booths must be open and staffed during show hours (Thursday optional). Any displays will not visually or physically disturb adjacent exhibitors. All displays must conform to the Rules and Regulations of the San Francisco Fire Department. Booth space may not be sublet and only merchandise specified in the show contract may be displayed. Displaying any other merchandise without prior consent of the Management is forbidden. Management reserves the right to adjust space assignments at any given time. **No refunds will be issued to an exhibitor who fails to occupy its space.** Violation of these terms and conditions may result in forfeiture of space. **Refunding fees is at the sole discretion of Management.** Management reserves the right to reject or restrict any exhibit. Exhibitors shall not cause undue noise, odor or damage to the environment, facility or booth equipment or act in any manner deemed inappropriate by Management. No exhibitor shall have authority to incur cost or liability for or against the Giant Race event, Giants Enterprises, or Evolve Sports, LLC, its partners, sponsors, volunteers or the expo facility. Exhibitor shall pay for all costs pertaining to load-in and load-out and shall be liable for all damages which may be caused to the environment, or otherwise, in connection with the exhibit. Serving of alcoholic beverages and/or foods is prohibited without prior written permission from Management. Exhibitor assumes all responsibilities for loss, theft, or destruction of goods or for personal injuries to themselves, their employees, agents, representatives, or visitors, and will save harmless the Giant Race event, Giants Enterprises Evolve Sports, LLC and the expo facility from any liability in connection any and all of the above. Exhibitor assumes the entire responsibility and liability for losses, damages and claims arising out of their own activities on the premises of the Giant Race event and shall indemnify, defend and hold harmless the Giant Race event, Giants Enterprises and Evolve Sports, LLC from any such losses, damages and claims. Exhibitor must provide workmen's compensation, comprehensive general liability including products and completed operations, independent contractors, personal injury and blanket contractual liability. **This must be evidenced by a certificate of insurance with a 30-day notice of cancellation provision to the holder and supplied to Management at least 30 days before the exhibit date.** This agreement shall be governed and construed by California state law and any disputes between parties shall be brought in the courts of California.
